The End of Year Full Moon Party Terms and Conditions

In these terms and conditions 'UHSU' refers to University of Hertfordshire Students' Union, 'You' 'Your' refers to you as a student at University of Hertfordshire or a guest using UHSU website.

Purchasing Tickets

1. If you wish to attend the **End of Year Full Moon Party** at The Forum you are required to purchase a ticket using the Students' Union's website or from the Students' Union front desk on College Lane or De Hav. In the event of a problem with the website/app or in exceptional cases, it is possible to purchase a ticket at the Union Helpdesk.
2. If you or your guests are on the banned list you may purchase a ticket if the ban expires before the end of the night on Thursday 9th May 2024. You cannot purchase a ticket for any person(s) who has a ban that will still be in force on the night.
3. You are eligible to purchase a maximum of three tickets with two of these assigned to guests.
4. If purchasing online, you will receive confirmation of purchase by email within 24 hours of the purchase to your registered account, this will generally be your university email address. If purchasing at the Students' Union front desk, your tickets will be viewable on the website by logging in and navigating to 'Purchase History' on your account options.
5. An order for tickets is not complete until accepted by us. We try to ensure all prices are accurate but errors may occur. If we discover an error in the price of tickets you have ordered we will inform you as soon as possible and we may either cancel the order (in which case you will be refunded the ticket price and any booking, transaction or supplementary fees you have paid) or give you the option of confirming your order at the correct price.

Collecting Your Ticket

1. Your guest(s) must be present with you to exchange their ticket(s) as wristbands.
2. Wristbands will be secured to individuals at this time.
3. Your guest(s) must present valid photographic ID (valid photo driving licence, passport, PASS holographic ID card) when exchanging their ticket.
4. All guests will be required to 'Sign In' at the time of exchange of wristbands, in line with Students' Union membership regulations. Members must present a valid UH ID card when exchanging their ticket.

Entering the Venue

1. A ticket will guarantee you entry into the **End of Year Full Moon Party** until 11pm on Friday 10th May 2024. In the event of the guaranteed time changing this will be clearly communicated on the event webpage.
2. Should you leave the **End of Year Full Moon Party**, no re-entry is permitted.
3. Anyone attempting entry without a valid ticket will be subject to the venue's Disciplinary Policy and may face disciplinary action including instant banning.

Cancellation Rights and Refunds

1. Tickets cannot be exchanged, refunded, re-sold or transferred once purchased.
2. Tickets are non-transferable and cannot be sold on. Any student selling or attempting to sell a ticket will be subject to disciplinary action and risk being banned from the Students' Union venues.

Use of Images

1. The **End of Year Full Moon Party** will be photographed, filmed, and elements may be streamed via live webcast by us or our agents. By purchasing a ticket to this event you consent to the recording and transmission of images (both still and moving) of you and your guests as members of the audience. We retain all rights in any images, which can be used for publicity purposes and marketing materials. If you'd prefer your image not to be used in materials, please email contact@hertssu.com identifying the image/video.
2. During the event, if you consent to an image being taken by one of our photographers, these will potentially be uploaded to our social media channels for publicity and marketing purposes.
3. If you have any objection to being photographed/recorded while at the the **End of Year Full Moon Party**, please make yourself known to our photographer/videographer.
4. When you are purchasing a ticket for the **End of Year Full Moon Party** you are agreeing to attend the event and all acts, content, entertainment and date can change without prior notice and no refunds will be given.

Force Majeure

1. If the **End of Year Full Moon Party** cannot take place or is delayed because of circumstances beyond our reasonable control, we will not be liable for any direct or indirect losses incurred by you or your guests. Examples of such circumstances include (without limitation): war, terrorism, civil commotion, fire, flood, adverse weather, natural disaster, act of God, outbreak of disease, epidemic, pandemic, any strike or labour dispute, interruption or failure of any utility service, any government order, rule regulation, or action by a government or public authority.
